-Services will be provided in an effort to ensure residents and/or businesses access to their assigned spaces and/or garages, and to conform with the demands regarding public safety and emergency vehicle access set forth by the San Diego County Fire Department.

-Western Towing agrees to respond to the property within a reasonable period of time when summoned by management or an authorized agent for the purpose of removing any vehicles that are not in compliance with the property or business regulations. Western Towing agrees to conduct random on-site inspections of the fire lane/red zone areas and for vehicles parked in a manner that restricts ingress or egress to the property. ( Check box to indicate approval for on-site inspections.)

-Western Towing will, as prescribed by law, promptly report all impounded vehicles, to the appropriate law enforcement agency and will perform all operations within the guidelines set forth in Section 22658 of the California Vehicle Code.

-Western Towing agrees that their employees will act and conduct themselves in a professional manner on and off the above property address. This agreement is effective upon signature and may be canceled by either party notifying the other in writing. Service shall immediately cease upon receipt of a written cancellation request by either party.

-Western Towing is responsible and liable for any damages to vehicles resulting or arising from Western's actions or omissions in conducting tows from your property. Resolution of any dispute in this regard shall be a matter entirely between Western and the vehicle owner(s). Western agrees to indemnify and hold the Property Owner/Agent harmless related to any (1) Code violations or (2) property damages which are alleged to have arisen from Western's actions or omissions during the impound process.

By signing my signature below I certify as an agent that I authorize Western Towing to a general towing authorization of the firelanes, fire hydrants, stenciled red zones and for vehicles parked in a manner that restricts access to the property at the above mentioned address.
